Website Privacy Notice

As a healthcare company, Camurus Pty Ltd (**Camurus**) recognises the importance of privacy and is committed to the management and handling of Personal Information and Sensitive Information in an open and transparent way. Camurus is required to comply with the Australian Privacy Act 1988 (Cth) (**Privacy Act**) and this Website Privacy Notice, together with <u>Camurus' Privacy Policy</u>, creates a framework to ensure that any Personal Information Camurus holds is collected, used, stored and disclosed in accordance with the Australian Privacy Principles in the Privacy Act. Camurus' parent company and many Camurus affiliates are subject to the European General Data Protection Regulation (**GDPR**). Personal Information

The information collected will be necessary for the operation of this website by Camurus, and will be collected fairly and lawfully. Cookies

IP Addresses
